**Terms & Conditions (Part 1 of 2)**

By registering and attending the Second International Conference of Deaf Muslims (heretofore referred to as ICDM), to be held from 27 November to 30 November 2016 at the Hotel Istana in Kuala Lumpur, Malaysia, each participant acknowledges and agrees to the following terms and conditions as the criteria of being accepted to attend the conference.

Release of Liability

All participants are solely responsible for any financial, physical, or legal liability that they may incur before, during, or after their participation in ICDM. Participants agree to assume all incurred costs, including, but not limited to, transportation, flights, and hotel stay. **Global Deaf Muslim (GDM), the Malaysian Federation of the Deaf (MFD), the Malaysian Deaf Muslim Association (PRISMA), and all other conference organizers and sponsors are fully released from any financial, physical, or legal liabilities that participants may incur as a result of their participation with the conference.**

Registration & Early Bird Discounts

All individuals wishing to attend ICDM must be completely registered, having provided all required information, and paid in full before entering the conference venue. You may register on behalf of others however you are deemed to be liable for the participants you register. **There will be no on-site registration.** The last day to register for the conference will be **20 November 2016.**

Refunds

Accessibility Needs

Travel & Health Insurance Coverage

It is the responsibility of all participants to arrange appropriate insurance coverage (e.g. health insurance, travel insurance, etc.) as they deem necessary during their participation in the conference. Conference Decorum

### Age of Participation

**All participants must be a minimum of 18 years of age to attend the conference.** Children under the age of 18 are NOT permitted in the conference venue while the conference is in session. It is the parent's responsibility to provide adequate child care before the conference commences. Anybody violating this policy will be asked to leave the session. Children are permitted to attend during meals and refreshment times only.
